
Previous Minutes

Confirmation of Previous Minutes

Business arising from Previous Minutes

- Insurance Insurance premium has been paid.
- <u>Sponsorship</u> Peter is following up with potential sponsors. Also looking at people to do the sponsorship artwork. Various alternative sponsors suggested to be contacted.



 females on our email list to see if we can determine what the blockers might be.
 Ron suggested that a positive thing to do would be for the BUG to support the
 Nicola Davies Memorial Ride.
- (Rahat) Standing Items Rahat queried whether the committee had "Standing Items". Lee explained that until fairly recently we did and our minutes had a very comprehensive "Standing Item" structure but we found the minutes contained quite a few pages of headings with many items having nothing to record in them. It probably is a good idea to bring some of that back to give the meetings a bit more structure.
- (Mark) Online Membership Form Mark queried if one was available as he
 believed that unless people could follow though and join the committee from the
 website we would lose potential members who would not get around to following
 up on the joining process. Ron to supply his membership form to Ashley to try
 and make it available via the website.
- (Graeme) 2-Way Radios Graeme reported that we were using 3 2-way radios on the rides, one each with the Ride leader, someone in the middle of the group and Tail End Charlie and they were proving quite useful for keeping the group together.
